A. STATUS AND SCOPE OF THE POLICY BEING ASSESSED

For the purposes of this assessment, the term 'Policy' refers to a Policy, Strategy, Programme, Procedure, Function or Decision.

A1. What are main aims, objectives, purpose and intended outcomes of the Policy?

The Cambridge Northern Fringe East Area Action Plan (CNFE AAP) will build on national policy, including in the National Planning Policy Framework and National Planning Practice Guidance and Policy SS/4 in the Submission South Cambridgeshire Local Plan (and Policy 14 in the submitted Cambridge Local Plan). The CNFE AAP will contain a number of policies relating to the redevelopment of the land around the Chesterton Sidings (some of which is within Cambridge City) for mixed-use development.

The Issues and Options report is the first stage of producing the CNFE AAP, which will be published for public consultation. The results of the consultation will inform the development of the CNFE AAP.

The project objectives are to:

- i) Achieve the regeneration of CNFE through a high quality employment led mixed use development;
- ii) Contribute to meeting the employment and housing needs of the sub-region;
- iii) Provide a high quality gateway to the city and an area which is an important and attractive destination in itself;
- iv) Contribute to the wider growth agenda of the area, including the retention and enhancement of a strategic rail freight head;
- v) Enhance the transport, water, community and social infrastructure and environmental assets in the north-east of Cambridge.

A2. What is the status of this Policy? (New, existing or under review)

The CNFE AAP will form one of a suite of documents that make up the Council's Development Plan. It will amplify Policy SS/4 in the Submission Local Plan, which is currently the subject of Examination by an independent planning Inspector.

It is also linked with all three of the Council's Aims.

A3. What is the timescale and decision-making route for approval of the Policy?

The CNFE AAP will go through the following stages:

Issues and Options consultation (the current stage) – 8 December 2014 to 2 February 2015

- Pre-Submission public participation September to October 2015
- Draft Plan submitted to the Secretary of State April 2016
- Independent Examination into the soundness of the Plan by a Government Planning Inspector April to September 2016
- Adoption October 2016

The Issues and Options Report has already been considered by the Joint Transport and Spatial Planning Group on 28 October 2014, which recommended that the councils agree the draft Issues & Options Report for consultation. It is being reported to the Planning Portfolio Holder on 18 November 2014 for agreement to undertake consultation. The results of the consultation will be reported to future meetings.

A4. Is this policy associated with the Council's strategic Aims, Approaches and Actions (The Three 'A's)? If so, please state the relevance and association to The Three 'A's.

Aim 1 - We will listen to and engage with residents, parishes and businesses to ensure that we deliver first class services and value for money.

Consultation on Issues and Options will provide the opportunity for all stakeholders to influence the policies and proposals for this area of the district before the Council prepares the CNFE AAP.

Aim 2 - We will work with partners to create and sustain opportunities for employment, enterprise and world leading innovation.

The CNFE area is proposed for mixed-use development, including employment uses.

Aim 3 - We will make sure that South Cambridgeshire continues to offer an outstanding and sustainable quality of life for our residents.

The Council has a duty to contribute to sustainable development. This lies at the heart of the Local Plan and covers all three aspects of sustainability – economic, social and environment. The Plan has a focus on sustaining and enhancing the qualities of South Cambridgeshire that in national surveys consistently identify the District as one of the best places to live in the UK.

A5. Who are the intended beneficiaries/stakeholders of the policy or function? How many people are affected and from what sections of the community?

Consultation and community engagement will be undertaken in accordance with the agreed strategy being considered by the Planning Portfolio Holder on 18 November 2014. Consultation on Issues and Options will provide the opportunity for all stakeholders to influence the policies and proposals for this area of the district before the Council prepares the CNFE AAP.

The delivery of development outlined in Local Plan Policy SS/4 will assist the local economy as well as new and existing residents within the district. The CNFE AAP will deliver a mixture of employment, residential, recreational and other community uses with the intention of creating balanced communities. Delivery of the site allocation will involve a number of stakeholders to ensure the provision of all necessary infrastructure to serve the development.

A6. Are external partners involved in delivering this policy? If so, what are their roles, and level of involvement/influence?

The CNFE AAP is being prepared in partnership with Cambridge City Council. Cambridgeshire County Council is a key stakeholder assisting the project. Delivery of development on the site allocation will involve a number of stakeholders to ensure the provision of all necessary infrastructure to serve the development.

Most of the indicators are existing indicators which are already monitored and reported in the Annual Monitoring Report. Any new indicators will be reported on when data becomes available.

The CNFE AAP will set out the policy framework for future development of the site, and address the provision of a safe and accessible environment for all people, with development that meets the needs of everyone, for example in terms of community facilities and housing mix. The CNFE AAP policies will be used in the development of a Masterplan for the development site and in the determination of planning application(s). Therefore it may be possible to monitor how well the policies are be implemented through the planning application process.

B4. Have you consulted or involved external stakeholders about the policy or function? If so, what were their views?

The CNFE AAP Issues and Options report has been prepared in partnership with Cambridge City Council and close working with Cambridgeshire County Council. It has also been informed by a visioning workshop with key stakeholders which took place on 12 April 2013, and the views of key stakeholders as a result of early evidence gathering and consultations undertaken since February 2014.

The Issues and Options public consultation will provide the opportunity for wider stakeholder involvement. The results of the consultation will inform the development of the CNFE AAP.

B5. Have you undertaken any consultation with staff to assess their perception of any impacts of the policy or function? If so, what has been learnt from them?

A range of staff were involved in the early development of the Issues and Options report, including Environmental Health, Urban Design, Development Control and Highways officers.
